- Discuss/Approve AN ORDINANCE 2019-02 providing for the issue of not to exceed \$6,000,000 General Obligation Park Bonds, Series 2019A, of the Flagg Rochelle Community Park District, Ogle County, Illinois, for the purpose of building and equipping a Community Center, providing for the levy of a direct annual tax sufficient to pay the principal and interest on said bonds and authorizing the sale of said bonds to Mesirow Financial, Inc.
  - O District Municipal Advisor, Tom Chapman of Raymond James explained that the 2 ordinances presented are to give the board the most flexibility. They would be approving these and giving the financial committee and District staff the ability to make the best decisions when the bonds go into the market.
